

**WAIVER OF CLAIMS, RELEASE, AND HOLD HARMLESS AGREEMENT**

I, and/or my child or ward, \_\_\_\_\_, am/is about to participate voluntarily in various activities, including flying activities and the use of one or more aircraft (collectively, "**FWFC Activities**"), of the Fort Worth Flying Club ("**FWFC**") as a pilot, student pilot, copilot, instructor, or passenger. In consideration of FWFC permitting me and/or my child or ward to participate in the FWFC Activities, I, for myself, my child and/or ward, and each of our heirs, beneficiaries, next-of-kin, other family members, administrators, executors, personal and other representatives, subrogees, successors, and assigns, and any and all persons claiming or potentially claiming by, through, or under any of the foregoing (each a "**Releasing Party**"; collectively, the "**Releasing Parties**"), hereby **WAIVE, RELINQUISH, FULLY RELEASE, FOREVER DISCHARGE**, and covenant and agree to never institute or prosecute, or in any way aid in the institution or prosecution of, any demand, claim, or suit against FWFC, the owner(s) of the subject aircraft, each of their respective partners, shareholders, members, managers, directors, officers, agents, employees, successors, or assigns, or any heirs, beneficiaries, next-of-kin, other family members, administrators, executors, or personal or other representatives of any of the foregoing (each a "**Released Party**"; collectively, the "**Released Parties**"), acting officially or otherwise, for any loss, damage, or injury to my and/or my child's or ward's person (including death) or my and/or my child's or ward's property which may occur from any cause whatsoever as a direct or indirect result of my and/or my child's or ward's participation in FWFC Activities, **REGARDLESS OF WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES.**

Furthermore, I, for myself and the other Releasing Parties hereby covenant and agree to **INDEMNIFY, DEFEND**, and **HOLD HARMLESS** each of the Released Parties from any and all losses, claims (including, without limitation, claims involving strict or absolute liability in tort, damage, injury, death, liability, and third party claims), damages, liabilities, fines, penalties, demands, costs, and expenses of every nature (collectively, the "**Liabilities**") arising from any cause whatsoever as a direct or indirect result of my and/or my child's or ward's participation in FWFC Activities, **REGARDLESS OF WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF ANY OF THE RELEASED PARTIES.**

I agree to abide by all rules and requirements of the FWFC in connection with my and/or my child's or ward's participation in FWFC Activities. I understand and agree that FWFC officers are not responsible for the actions of its individual members.

If I, or any other Releasing Party, should demand, claim, or sue, or aid in any way in a demand, claim, or suit against, any Released Party, then I, for myself and the other Releasing Parties, hereby covenant and agree to **INDEMNIFY, DEFEND**, and **HOLD HARMLESS** each of the Released Parties from any and all Liabilities that may be incurred as a result thereof.

I understand and agree that I am **ASSUMING THE RISK** of personal injury (including death) or property damage to me and/or my child or ward that may result while participating in FWFC Activities.

I also understand and agree that I may be held liable for any Liabilities to the Released Parties which are caused by my and/or my child's or ward's participation in FWFC Activities, including my and/or my child's or ward's negligence, gross negligence, willful misconduct, or fraud.
